

**Contest Rules**  
***Dream big with \$10,000***  
**presented by iA Auto and Home Insurance**

The *Dream big with \$10,000* contest (hereinafter the “Contest”) is held and organized by Industrial Alliance Auto and Home Insurance Inc. (hereinafter the “Organizer”).

**1) ELIGIBILITY**

The Contest is open to all Quebec residents aged 18 or over.

The following individuals are excluded from the Contest:

- Employees of the Organizer as well as persons residing with these employees.
- Employees of Industrial Alliance Insurance and Financial Services Inc. (hereinafter “iA Financial Group”) and its subsidiaries, including financial security advisors and persons residing with these employees.
- Managing general agents, i.e., financial security advisors authorized to make referrals to the Organizer and persons residing with them.
- Advertising and marketing agencies, suppliers of prizes, materials or services related to the Contest.
- Employees of business partners of the Organizer, including automobile dealerships.

Entrants who use an alias, the name of a person under 18 years of age or any other substitutions of a name are also ineligible for the Contest prize.

**2) HOW TO ENTER**

The Contest is free to enter and no purchase is necessary.

You can enter by obtaining a quote, i.e. receiving a price, for auto insurance or home insurance:

- Using the VIP line at 1-866-650-4641 and mentioning the contest code received from one of our financial security advisors from one of the iA Financial Group agencies or other financial security advisors authorized to make auto and home insurance referrals.
- Using an online insurance quote web link specifically provided by one of our financial security advisors who is authorized to make referrals online, to complete a quote request online.

The entrant must have completed the online auto or home insurance quote request between Monday, January 1, 2024, and Tuesday, December 31, 2024, inclusive.

No purchase is required. The quote request completed with one of our property and casualty insurance agents on the VIP line of Industrial Alliance Auto and Home Insurance Inc. or completed online within the required timeframe provides one (1) chance for the entrant to win the prize.

The action of completing a quote request for one of the abovenamed insurance products during the Contest period gives the entrant one (1) chance to win. Only one quote request will be accepted for the purposes of this Contest, for a maximum of one (1) chance of winning during the Contest period. Once the quote request is completed, you will be automatically entered in the Contest.

The entrant is the person who completed the quote (over the phone or online) and if declared the winner, the prize will be awarded to this person.

**3) ENTRY RESTRICTIONS**

Limit of one (1) contest entry per person for the entire Contest period. Any attempts to exceed the number of permitted entries, specifically by using multiple or different email addresses, identities, registrations or logins nullifies all entries submitted by the entrant and will result in immediate disqualification. Any and all use of automated devices, robots, scripts, macros or automated Contest entry services will result in the immediate disqualification of all entries submitted by the entrant.

**4) CONTEST PERIOD**

The Contest starts on Monday, January 1, 2024, at midnight (ET) and ends on Tuesday, December 31, 2024, at 11:59 pm (ET).

## 5) PRIZES

Each month during the contest period, four (4) finalists will be drawn and will each win \$100 in the form of a cheque, for a grand total of forty-eight (48) finalists.

At the end of the year, once all monthly draws have been completed and the finalists have been contacted, a grand draw will take place among the forty-eight (48) finalists and the winner will receive the grand prize of \$10,000 in the form of a cheque.

At the end of the Contest period, the Organizer will have distributed forty-eight (48) cheques of \$100 each and one (1) cheque in the amount of \$10,000, for a total prize value of \$14,800.

## 6) ACCEPTANCE OF CONTEST RULES

By entering the contest, the entrant agrees to comply with the Contest rules and all decisions of the Organizer.

The Organizer reserves the right to disqualify any entrant or contest entry that does not comply with the contest rules.

## 7) ODDS OF WINNING

The odds of becoming a finalist and winning one of forty-eight (48) prizes of \$100 will be dependent upon the number of eligible entries received every month during the Contest period, as well as the moment at which the entrant registers for the Contest. Entrants are only eligible for the draw associated with the month they enter the Contest.

For example, a client's entry for a quote obtained in August will only count for the August draw. Entrants have a maximum of one (1) eligible entry for the entire Contest period.

Once the entrant has been declared a finalist, their odds of winning the grand prize of \$10,000 is one (1) in 48

## 8) PRIZE DRAWS

### Finalists of the draws for \$100

The forty-eight (48) finalists of the Contest will be determined by an electronic draw by a designated official at the head office of the Organizer, at 1080 Grande Allée West in Quebec City.

During the Contest period, monthly draws will take place quarterly, at 11:00 am (ET) on the first Wednesday following the last day of the quarter, from among all entrants who have qualified for each month of the quarter preceding the draw. All prize draw dates are detailed in Appendix II of these Contest rules.

Maximum of one (1) prize of \$100 per entrant for the entire Contest period. In the event that the same entrant is drawn a second time, the Organizer will draw again.

### Winner of the grand prize of \$10,000 in the form of a cheque

The winner of the grand prize of \$10,000 will be determined by an electronic draw on Microsoft Teams among the monthly-prize-winning finalists by a designated official at the head office of the Organizer, at 1080 Grande Allée West in Quebec City. The draw will take place at 11:00 am (ET) on Wednesday, February 26, 2025.

## 9) CLAIMING THE PRIZE

To be declared the winner, subject to eligibility, the entrant chosen by random draw must:

- b) Correctly answer a mathematical skill-testing question posed by the Organizer at the time of the initial communication.
