OPEC extends its cuts

World

The Organization of the Petroleum Exporting Countries (OPEC) has agreed to extend by nine months its agreement to reduce its total oil production by 1.8 million barrels per day (the agreement was to end in March 2018). It should be noted that Russia has also decided to remain in the agreement. The agreement could set a floor price on oil, as the oil market recently benefited from an upward revision of the demand (reflecting the strength of the global economy), and a reduction of U.S. stockpiles.

WTI price in U.S. dollars

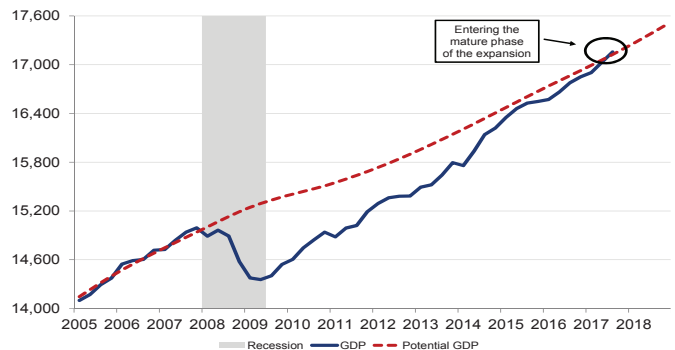


North America

The U.S. economy seems to be gaining strength. Consumption continues to be sustained by the performance of the job market and strong consumer confidence, and there is accelerated corporate investment. Also, the U.S. output gap (current GDP minus potential GDP) has now been closed, ten years after the Great Recession. We are now entering the mature phase of the expansion, a phase generally characterized by growing inflationary pressure and a tightening of monetary policies.

Financial markets

For more than a year, the economic environment has favoured equities; a synchronisation of global economic growth accompanied by a high level of monetary accommodation by central banks. Moreover, this environment has helped propel the stock market to new highs in 2017 and drive volatility to historical lows. While it is still too early to anticipate a downturn in the markets, we are keeping an eye on the fact that the yield curve continues to flatten, a sign that suggests, historically, less spectacular stock market returns.
