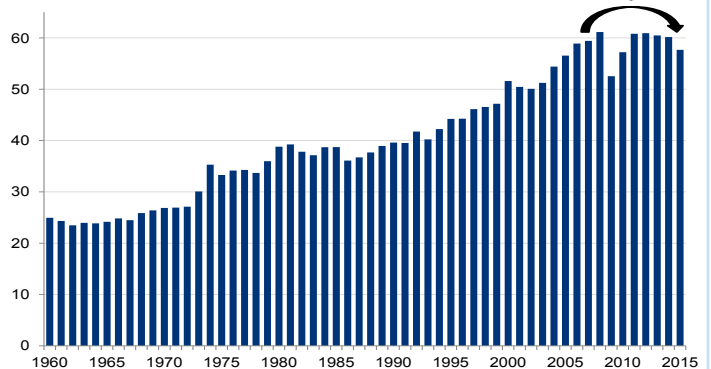

Protectionism is back

World

The opening of borders has contributed substantially to the acceleration of world economic growth in the last few decades, such that trade now accounts for more than 55% of global GDP. However, the recent rise in protectionist movements seen over the last few months in Europe (result of the British referendum) and in the United States (opposition to the Trans-Pacific Partnership) could upset the applecart and act as a headwind to economic growth in the coming months.

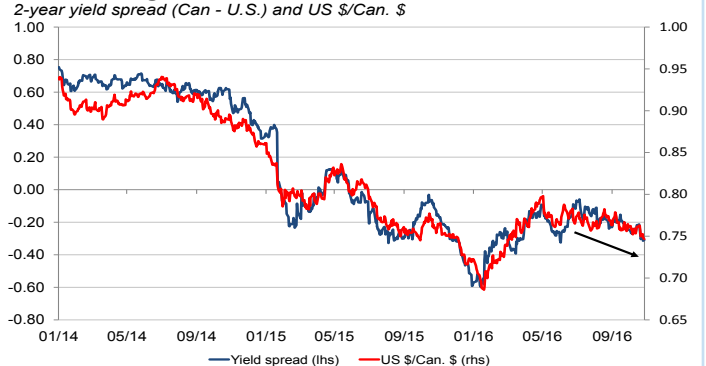
World trade: Have we reached the peak?

North America

The Bank of Canada has lowered its forecast for Canadian economic growth for both this year (1.1% vs. 1.3%) and 2017 (2.0% vs. 2.2%). The BoC is concerned by the weakness in exports and investments by Canadian businesses. On the other side of the border, the U.S. economy appears ready to support a second increase in its key interest rate in the very near future. This difference in tone between the two central banks has weighed on the Canadian dollar over the last few months.

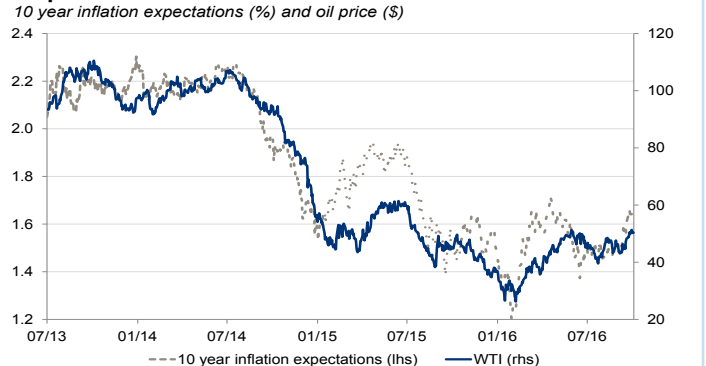
Canada vs. U.S.: Relation between yield spread and exchange rates

Financial markets

The desire within the Organization of the Petroleum Exporting Countries (OPEC) to cooperate on a possible production cut has helped raise inflation expectations in the United States over the last few weeks. The effect has manifested itself in the yield on the benchmark 10-year U.S. Treasury note, which went from 1.59% to 1.85% in October. More positive economic data in Europe and increased expectations of a rate hike by the Federal Reserve this coming December also contributed to this movement in rates.
